# **Overactive Bladder (OAB) Treatment Information**

#### Indication

BOTOX<sup>®</sup> is a prescription medicine approved to treat overactive bladder symptoms such as a strong need to urinate with leakage or wetting accidents, urgency, and frequency in adults when another type of medication (anticholinergic) does not work well enough or cannot be taken.

#### **IMPORTANT SAFETY INFORMATION**

BOTOX<sup>®</sup> may cause serious side effects that can be life threatening. Get medical help right away if you have any of these problems any time (hours to weeks) after injection of BOTOX<sup>®</sup>:

- Problems swallowing, speaking, or breathing, due to weakening of associated muscles, can be severe and result in loss of life. You are at the highest risk if these problems are pre-existing before injection. Swallowing problems may last for several months
- Spread of toxin effects. The effect of botulinum toxin may affect areas away from the injection site and cause serious symptoms including: loss of strength and all-over muscle weakness, double vision, blurred vision and drooping eyelids, hoarseness or change or loss of voice, trouble saying words clearly, loss of bladder control, trouble breathing, trouble swallowing

# Recognizing when you may be ready to talk to a doctor

# Are you just coping with your OAB symptoms?

## Coping with symptoms isn't the same as controlling them

Many with OAB still have symptoms such as leaking, going too often, and the strong and sudden need to go.

## Signs that you're just coping with OAB include:



- Using multiple leakage pads per day
- Planning all your travel around bathroom locations
- Not doing things you like because of the fear of leakage
- Worried about the problem every day

### IMPORTANT SAFETY INFORMATION (continued)

**Do not take BOTOX® for the treatment of urinary incontinence if you:** have a urinary tract infection (UTI) or cannot empty your bladder on your own (and are not routinely catheterizing). Due to the risk of urinary retention (difficulty fully emptying the bladder), only patients who are willing and able to initiate self-catheterization post-treatment, if required, should be considered for treatment.

# Have you already tried OAB medications?

## Did you discover that oral medications:

According to 2 separate surveys, the top reasons that OAB patients discontinued oral medications were side effects and/or lack of results.

## Learning about this option for your next step in treatment

# It's time to consider BOTOX®

The American Urological Association (AUA) treatment guidelines recognizes BOTOX<sup>®</sup> as one of the treatment options to consider if:

- You tried self-management (such as pads or drinking less liquids), but it didn't work
- You tried oral medication and either it didn't work or was difficult to tolerate

#### IMPORTANT SAFETY INFORMATION (continued)

Tell your doctor about all your muscle or nerve conditions such as ALS or Lou Gehrig's disease, myasthenia gravis, or Lambert-Eaton syndrome, as you may be at increased risk of serious side effects including difficulty swallowing and difficulty breathing from typical doses of BOTOX<sup>®</sup>.

# Calm your bladder with BOTOX®

BOTOX<sup>®</sup> is different from other treatments. BOTOX<sup>®</sup> is placed in the bladder muscle to target the source of your OAB.



- In your body, certain chemicals travel from nerve cells to muscle cells to make your bladder contract so that you can urinate
- For people who have OAB, these muscles contract uncontrollably, creating leakage, the strong sudden need to go, and going too often

# BOTOX<sup>®</sup> is placed in the bladder muscle, where it helps block the nerve signals that trigger OAB

- Reduces daily leakage episodes by half or more
- Treats the strong need to urinate right away
- Reduces the number of times you need to empty your bladder each day

### ▶ If you want OAB symptom relief, BOTOX<sup>®</sup> can help. Individual results may vary.


### **IMPORTANT SAFETY INFORMATION (continued)**

Tell your doctor about all your medical conditions, including if you: have or have had bleeding problems; have plans to have surgery; have symptoms of a urinary tract infection (UTI) and are being treated for urinary incontinence. Symptoms of a urinary tract infection may include pain or burning with urination, frequent urination, or fever; have problems emptying your bladder on your own and are being treated for urinary incontinence; are pregnant or plan to become pregnant (it is not known if BOTOX® can harm your unborn baby); are breastfeeding or plan to (it is not known if BOTOX® passes into breast milk).



# OAB control for people who have already tried oral therapy

In 3 clinical trials, 3 months after treatment, compared to placebo BOTOX<sup>®</sup> was proven to significantly reduce daily leakage episodes



Average decrease in leakage episodes in clinical studies

If oral medication isn't working or you can't take it because of side effects, you may be ready for BOTOX<sup>®</sup>.

# BOTOX<sup>®</sup> reduced daily leakage episodes by half or more

## At week 12 in clinical trials:



The majority of patients receiving BOTOX<sup>®</sup> had **at least 50% reduction** of daily leakage episodes.



Many of these patients **reduced their leakage** episodes by **75%**.



Approximately 1 in 4 patients reported leakage episodes stopped completely.

Reduction of Urinary Incontinence (UI) episodes in 3 clinical trials:

Study 1: BOTOX® n = 280, placebo n = 277; Study 2: BOTOX® n = 277, placebo n = 271; Study 3: BOTOX® n = 145, placebo n = 60

- Patients with ≥ 50% reduction: BOTOX<sup>®</sup> 57.5%, 63.5%, and 77.2%; placebo 28.9%, 33.2%, and 33.3% (P < .001)
- Patients with ≥ 75% reduction: BOTOX<sup>®</sup> 44.6%, 47.3%, and 55.2%; placebo 15.2%, 20.3%, and 21.7% (P < .001)
- Patients with 100% reduction: BOTOX<sup>®</sup> 22.9%, 31.4%, and 33.8%; placebo 6.5%, 10.3%, and 11.7% (P < .001)

# By significantly reducing daily leakage episodes, BOTOX<sup>®</sup> may positively impact your daily life

## Results of a questionnaire:

Patients in BOTOX<sup>®</sup> clinical trials reported improvement in their overall quality of life based on 3 categories<sup>\*</sup>:



# Avoidance and limiting behavior

Such as overplanning every detail of your day in advance, worrying about where bathrooms are, and limiting how much fluid you drink.



# Psychosocial impact

Such as being preoccupied or frustrated with how your condition impacts your everyday decisions, such as what you can wear, where you can go, and how you feel about your overall well-being.



## Social embarrassment

Such as being embarrassed or worried that your symptoms might be noticed by others.

\*These improvements were reported using the Incontinence Quality of Life questionnaire (iQOL). This is a validated questionnaire that is used to measure the impact of urinary incontinence on a patient's quality of life.

The most common side effect, urinary tract infection, was experienced by approximately 18% (vs 6% in placebo) in clinical trials for OAB. Other most common side effects include painful

or difficult urination, and temporary inability to fully empty your bladder. This list does not cover all the possible serious side effects

# What to expect with treatment



You may see results after just 2 weeks (you'll have a week-2 follow-up visit)



Symptom check around 4 months (by phone or office visit)



BOTOX<sup>®</sup> may last up to 6 months In clinical trials, BOTOX<sup>®</sup> provided up to 6 months of OAB symptom improvement.



Plan BOTOX<sup>®</sup> re-treatment as few as 2 times a year When your first BOTOX<sup>®</sup> treatment begins to wear off, **discuss re-treatment** and **setting up a regular re-treatment schedule** with your doctor. Wait at least 3 months between treatments.


